- ❖ SSC March 2026 result is available on Board's official website results.gbshsegoa.net.
- ❖ You are requested to download the consolidated results sheets from Goa Board's School Portal on 28/04/2026.
- ❖ For any corrections, it is the sole responsibility of the Head of Institution to appoint dealing hand for this purpose and the concerned shall be accountable to pay the necessary extra fees towards issue of any revised certificates after receiving Statement of Grades/Marks.
- ❖ It is to inform to verify the following details of the candidates in the result sheet of S.S.C. Examination of March 2026 and for any discrepancies immediately inform this office through mail or special messenger.
 - Name of the candidate/Mother/Father.
 - Date of Birth.
 - Subjects offered by the candidate.
 - Exemptions if any claimed by the candidate.
 - Name of the Centre.
 - Result (Especially if 'Pass' remark is printed by error when less than minimum marks for passing or absence is recorded in any subject).
 - Grade.
- ❖ To resolve any discrepancy, it is the sole responsibility of the Head of Institution. So school to appoint dealing hand for this purpose and the concerned shall be accountable to pay the necessary extra fees towards issue of any revised certificates after receiving Statement of Grades/Marks.

❖ **ONLINE APPLICATION TO APPLY FOR VERIFIED PHOTOCOPY/RE-EVALUATION OR VERIFICATION OF MARKS IN ABSENTIA FOR SSC 2026 MARCH EXAMINATION.**

a. The Portal (gbshse.gov.in) will be opened for the above from 28/04/2026.

The prescribed fees/date schedule is as follows:

SR NO	PARTICULARS	FEES	LAST DATE
1.	Verified Photocopy of the answer-book	₹ 350/- per subject	02/05/2026
2.	Re-evaluation of answer-books	₹ 700/- per subject	11/05/2026
3.	Verification of Marks in Absentia	₹ 100/- per subject	02/05/2026

b. **Please note:** If candidate applies for Verified Photocopy and/or Re-evaluation he/she is not permitted to apply for Verification of Marks in Absentia.

c. Schools are required to pay the fees through **PAYMENT GATEWAY** provided on the Goa Board Website.

d. The Head of Institution should categorically inform the candidates that totaling of marks and unassessed answers (if any) will be checked in the case of verified photocopy of the answer book(s).

However, candidate may apply for Re-evaluation if desires after obtaining photocopy but before the last date for Re-evaluation.

e. No candidate will be permitted to apply for Verified Photocopy/ Verification in Absentia/Re-evaluation of answer- book beyond the dates specified in this Circular.

f. On receiving Photo copy, the School should take responsibility of forwarding the verified Photocopy to the applicant/candidate(s) on the same day possibly through mail.

- g. Passing Certificates of March 2026 S.S.C. Examination shall be made available at later date.
- ❖ No separate intimation will be sent regarding declaration of result to the schools. All information pertaining to Exams will be available on the official website of this office.
 - ❖ Verified Photocopy of the answer-book/Verification in Absentia report will be sent to the school through e-mail. **The report will be uploaded on the official website.** The Verified Photocopy should be handed over to the student on the same day.
 - ❖ Upon receiving verification report, schools are advised to collect the revised marksheet (s) as per date specified in the report.
 - ❖ No result will be handed over to the candidate/s or parents even after producing authority letter from the school.
 - ❖ **All Heads of institutions are requested to convey parents not to visit this office for any type of discrepancies pertaining to the results. However, they may route their request through Head of the Institution through email. The Head of the Institution shall examine the request before forwarding to the Board.**
 - ❖ **School to constitute three member committee to address grievances regarding results of SSC March 2026 Examination.**
 - ❖ Tentative date of commencement of Second SSC Examination is on 06th June 2026.
 - ❖ The Circular should be displayed on the Notice Board at a prominent place for information of all concerned. Kindly acknowledge the receipt of this Circular through email.
